Teaching With Historic Places: "Separate But Equal? South Carolina's Fight Over School Segregation"

The National Park Service's Teaching with Historic Places program recently launched its 158th lesson plan, *Separate But Equal? South Carolina's Fight Over School Segregation*. The lesson helps students learn how segregation affected education in rural South Carolina in the 1940s and '50s, and how African American parents challenged this system for their children in *Briggs v. Elliott*— a case combined with *Brown v. Board of Education*. Students study South Carolina's reaction to the lawsuit, which was to fund new schools for all students, regardless of race, in order to preserve segregation. Students will also investigate the sleek, modern architecture and features of the "equalization" schools and consider the implications of "separate but equal." The lesson was written by Rebekah Dobrasko, historian with the Texas Department of Transportation, previously with the

Best of the South: Preserving Southern Architecture Award Nominations

The Southeast Chapter of the Society of Architectural Historians seeks nominations for the *Best of the South: Preserving Southern Architecture Award*. This annual award honors a project that preserves or restores an historic building, or complex of buildings, in an outstanding manner and that demonstrates excellence in research, technique, and documentation. Projects in the 12-state region of SESA (which includes South Carolina) that were completed in 2013 or 2014 are eligible. Nominations should consist of no more than two typed pages of description, and be accompanied by hard copy illustrations and any other supporting material. A cover letter should identify the owner of the project, the use of the building(s), and the names of all the major participants of the project.
